The Law Society of Upper Canada, the Canadian Association of South Asian Lawyers, the Federation of Asian Canadian Lawyers, and the South Asian Bar Association are pleased to hold an annual panel discussion and reception to celebrate Asian and South Asian Heritage Month in the legal profession. PANEL DISCUSSION:

Balancing Rights in a Multicultural Society – The Impact of Cultural and Social Issues on the Law

In 2013, the Supreme Court of Canada released decisions in two important cases that attempted to address a recurring question in Canada's increasingly pluralistic and multicultural society: How do we reconcile and balance competing rights and values in situations of actual or apparent conflict? In *R. v. N.S.*, the Court considered whether the right of an accused person to make full answer and defence required a key witness to remove her niqab while testifying in court, contrary to her religious beliefs. In *Saskatchewan Human Rights Commission v. Whatcott*, the *Charter* guarantees of freedom of expression and freedom of religion were pitted against Canada's legal and political commitments to promoting equality and human dignity. While the Court set out analytical frameworks to address the balancing of rights in these circumstances, these principles remain contested and contestable in other forums. These cases force us to grapple with the tensions and difficult questions associated with fostering a pluralistic and multicultural community. A panel of legal and policy experts dealing with these issues from various perspectives will continue the discussion about these important questions.
